Role Title: MUSINC Music leader (Assistant) – Self employed

Location: My place, Middlesbrough

Working Hours: Thursdays weekly 6pm - 8pm

Position in Organisation

Self-employed position, reporting to the MUSINC Project Coordinator.

Works in conjunction with: MUSINC project management staff, project partners and other self-employed music practitioners.

Overall purpose of the role

To deliver inclusive and high quality music making activities to young people with special educational needs and disabilities. Activities may involve both 1:1 and group work depending on the needs of the young people.

Responsibilities and Duties

To work within the Musinc team reporting to the Musinc project coordinator and manager, and to undertake the following duties:

- Work with the lead music leader to deliver a series of music making sessions with young people with special educational needs and disabilities.
- Undertake consultation with the young people at the start of your project, and use their input to inform planning for sessions.
- Find out about musical progression routes and signpost young people as appropriate
- Support young people's progression musically, personally and socially.
- Undertake induction and training around inclusion and working with young people in challenging circumstances.
- Work in line with the Youth Music Quality Framework. This will be covered in your induction and training.
- Work in partnership with the host organisation and/or setting staff within the venue you are
 working in, in order to best support the young people with their personal, social and musical
 development.

Please note: Successful candidates will receive a full induction covering processes and expectations which are specific to delivering a Musinc project.

Other duties and information:

 Seek to undertake professional development opportunities either provided by Musinc, or which you find through your own research, which will support the development of your skills in working with and for young people in challenging circumstances.

Knowledge, experience and skills required to carry out the role

Essential (required):

- Experience, or a strong interest in delivering inclusive music making sessions to young people with special educational needs and disabilities.
- Some understanding of the principles of Equality, Diversity and Inclusion, and a willingness to develop knowledge in this area.
- Knowledge and awareness of community music practice
- Knowledge and awareness of the wider music education sector and where to signpost progression opportunities for young people
- Good organisational skills
- Good communication skills
- Good time keeping
- Open mindedness in relation to musical genres and learning styles of young people.
- Some knowledge of a wide range of teaching and pedagogical approaches and a willingness to develop knowledge in this area.
- Awareness of reflective practice

Desirable (optional):

- Musical qualifications
- Teaching qualifications
- Knowledge and skills to facilitate urban genres of music and/or technology e.g. rap, grime,
 RnB and electronic.
